Qualifications

1. Applicants shall hold a Bachelor's Degree in Law.

- 2. Applicants shall pass the admission examination prescribed by the Program.
- 3. Applicants shall not commit an act which is attributable as a gross misconduct.
- 4. Applicants cannot study in more than one postgraduate program in the same time.
- 5. Applicants shall pass the English proficiency requirements as follows:
 - 5.1 A minimum TOEFL Internet based score of 79, or Chulalongkorn University Test of English Proficiency (CUTEP) score of 80, or IELTS score of 6.0, The submitted English proficiency score must not be issued for more than 2 years counting from the reporting day until the admission result announcement in each admission round. An applicant who made the submission in accordance with the aforesaid submission must comply with Clause 4 of the Announcement of the Graduate School of Chulalongkorn University re: Application and Admission of Graduate Programs for the 2022 Academic Year.
 - 5.2 An applicant may be exempted from the English proficiency requirements, both the Admission requirement of the graduate requirement, if he/she graduated from a program taught in English which is endorsed by the Office of the Civil Service Commission.
 - 5.3 * If an applicant has passed the admission examination (under clause 2 of this Attachment) but does not have the English proficiency score (under clause 5.1 of this Attachment), he/she can be admitted as a conditionally-accepted student. A conditionally-accepted student is required to pass the English proficiency requirements under clause 5.1 of this Attachment within the first semester of the 2022 Academic Year.

Remark*: Clause 5.3 is a resolution of the Chulalongkorn University Postgraduate Program Executive Committee in its meeting No.1/2565, dated 20th of January 2022. Please noted that, in order to graduate, a student is required to have a minimum TOEFL Internet based score of 79, or Chulalongkorn University Test of English Proficiency (CU-TEP) score of 80, or IELTS score of 6.0
