



**Chulalongkorn University Announcement**  
**Application for Studying in the Bachelor of Laws**  
**in Business and Technology Law (International Program), Faculty of Law,**  
**for the 2024 Academic Year (International Admission)**

Chulalongkorn University is accepting applications for students in the Bachelor of Laws in Business and Technology Law (International Program), Faculty of Law, for the 2024 academic year (International Admission). The application process is as follows.

## 1. Application Requirements

### 1.1 General Requirements

1.1.1 Must hold a foreign (non-Thai) passport

1.1.2 Must have completed or currently be studying in the final year at either type of the following programs:

(a) high school diploma or equivalent in a domestic or foreign educational institution **or**

(b) undergraduate degree or equivalent in a field other than law from a higher education institution in Thailand or overseas

Note: An institution in (a) or (b) must be certified by the Ministry of Higher Education, Science, Research and Innovation or the Office of the Civil Service Commission

### 1.2 Program Requirements

1.2.1 Must have demonstrated an adequate level of English proficiency by

(a) having completed or currently be studying in the final year of an English-taught undergraduate program or international undergraduate program from an institution that is certified by The Ministry of Higher Education, Science, Research and Innovation or the Office of the Civil Service Commission **or**

(b) having achieved at least the following score on any of these English proficiency tests. The test score must not be older than two years on the last day of application.

- IELTS (Academic) 6.5
- TOEFL iBT (internet-based) 79
- CU-TEP (Chulalongkorn University Test of English Proficiency) 88



1.2.2 Must have total score of at least 1200 on the SAT Evidence-Based Reading and Writing (EBRW) and Math sections, and an EBRW score of no lower than 500. The score of EBRW and Math sections must be from tests taken on the same test date and must not be older than two years on the last day of application.

Note: The SAT is not required for an applicant who has completed a bachelor's degree.

1.3 Must be an individual of good behavior who can commit to the university to study to the best of one's ability and be willing to strictly follow all current and future university regulations.

Should it emerge that an applicant is missing any of the preceding criteria or is found to have provided false information in the application or false or forged supporting documents, the applicant will be disqualified from this round of application, regardless of whether the application has been successful or not. The applicant may also face criminal charges.

## 2. Number of Available Places

Chulalongkorn University will accept a total of approximately **10 (ten)** qualified applicants in the Bachelor of Laws in Business and Technology Law (International Program), Faculty of Law, for the 2024 academic year (International Admission).

### 3.2 Application Fee Payment

#### 3.2.1 Application Fee

1,000 baht (one thousand baht).

#### 3.2.2 Methods of Application Fee Payment

The application fee must be paid before filling out the application form, in any of the following ways:

#### 4. Evidence and Supporting Documents

Applicants must complete the application form in full and ensure that all information is true and correct. The form must be accompanied by the following:

- 4.1 One 1-inch photo (The photo must be full-face view, without headwear or dark glasses, in student uniform or polite clothes, and no more than six months old.)
- 4.2 Copy of passport (signed true copy)
- 4.3 Copy of educational qualifications and transcript (signed true copy) or copy of student status from the applicant's current educational institution and latest transcripts (for current students)
- 4.4 Copy of English proficiency tests according to Clause 1.2 (signed true copy)
- 4.5 Resume or CV (pdf file of no more than two pages)
- 4.6 Copy of application fee payment 1,000 baht (one thousand baht) with the name of the applicant clearly visible

#### 5. Application Process

##### 5.1 First Round Applications

##### 5.1.1 Interview Shortlist Announcement

The Faculty of Law will announce the shortlist on 12 February 2024 at <https://law.chula-regist.com> with details for the interview.

##### 5.1.2 Interview (online)

Applicants deemed qualified for interview must attend an online interview approximately 16 - 20 February 2024, as specified by the Faculty of Law. An applicant who does not report for the interview on the date and time specified will be disqualified.

##### 5.1.3 Announcement of Admitted Applicants and Waitlisted Applicants

The Faculty of Law will announce the list of admitted applicants and waitlisted applicants who have passed the interview on 26 February 2024 at <https://law.chula-regist.com>.

##### 5.1.4 Enrollment Confirmation with Confirmation Fee Payment for Admitted Applicants

## 7. Other Conditions

7.1 A successful candidate with the right to matriculate must have received a high school diploma (Mattayom 6) or a bachelor's degree, or the equivalent of either, to be qualified to register as a student of Chulalongkorn University. Should it be discovered that the applicant did not complete the required education or does not possess all the qualifications, the right to matriculate will be rescinded and no application fee, confirmation fee, or university fee shall be refunded under any circumstances

Applicants who have received a high school diploma from an international school or a foreign school that is not certified by the Ministry of Education must have their qualifications certified by the Chulalongkorn University Academic Testing Center as equivalent to a qualification as required by the Ministry of Education's Basic Education Core Curriculum.

7.2 Should it emerge that successful candidates who have registered as Chulalongkorn University students have been found to have provided false information in the application or false evidence in support of the application or in the registration, their right to matriculate will be rescinded. The applicant may also face criminal charges.

7.3 Should it be found that successful candidates with the right to matriculate at Chulalongkorn University have confirmed their enrollment in more than one program, their right to matriculate in all such programs will be suspended without prior notice.

## 8. University Fees and Extra Surcharges

University fees and surcharges will be assessed according to announcements by Chulalongkorn University.
