### Qualifications

1. Applicants shall hold a Bachelor's Degree in Law or Equivalent.
2. Applicants shall pass the admission examination prescribed by the Program.
3. Applicants shall not commit an act which is attributable as a gross misconduct.
4. Applicants cannot study in more than one postgraduate program in the same time.
5. Applicants shall pass the English proficiency requirements as follows:
  - 5.1 A minimum **TOEFL Internet based score of 79**, or **Chulalongkorn University Test of English Proficiency (CUTEP) score of 80**, or **IELTS score of 6.0**, The submitted English proficiency score must not be issued for more than 2 years counting from the reporting day until the admission result announcement in each admission round.
  - 5.2 An applicant may be exempted from the English proficiency requirements, both the Admission requirement of the graduate requirement, if he/she graduated from a program taught in English which is endorsed by the Office of the Civil Service Commission.
