# 1. Application Requirements

- 1.1 Graduated from high school (or currently studying in the final year of high school) in a domestic or foreign educational institution, or the equivalent.
- 1.2 At least the following score on any of these English proficiency tests. The test score must be no older than two years on the last day of the application period.

IELTS (Academic) 6.5

- TOEFL iBT (internet-based) 79

- CU-TEP (Chulalongkorn University Test of English Proficiency) 88

- 1.3 Total score of at least 1200 on the SAT Evidence-Based Reading and Writing (EBRW) and Math sections, and an EBRW score of no lower than 500. The score of EBRW and Math sections must be from tests taken on the same test date and must not be older than two years on the last day of the application period.
- 1.4 An individual of good behavior who can commit to the university to study to the best of one's ability and be willing to strictly follow all current and future university regulations.

Should it emerge that an applicant is missing any of the preceding criteria or is found to have provided false information in the application or false or forged supporting documents, the applicant will be disqualified from this round of application, regardless of whether the application has been successful or not. The applicant may also face criminal charges.

# 2. Number of Available Places

Chulalongkorn University will accept a total of approximately **60 (sixty)** qualified applicants in the Bachelor of Laws in Business and Technology Law (International Program), Faculty of Law, for the 2026 academic year (Early Admission).

- 4.2.5 Copy of national identification card or passport (for non-Thai citizens) (signed true copy)
- 4.2.6 Copy of application fee payment 1,000 baht (one thousand baht) with the name of the applicant clearly shown.

Applicants must submit all documents, or the application will not be considered under any circumstances.

After the application has been made, it will be assumed that the applicant has made all preliminary checks. As such, the Faculty of Law will not refund application fees under any circumstances.

#### 5 Selection Criteria

#### 5.1 Selection Criteria for Interview

The Faculty of Law will select applicants for the interview based on the applicant's qualifications and SAT score in 1.3.

# 5.2 Announcement of Applicants Qualified for Interview

The Faculty of Law will announce the names of applicants qualified for interview on **7 January 2026** on https://law.chula-regist.com along with details for the interview.

The Faculty of Law may announce names of applicants qualified for interview than the number of available places when it may be thought that some applicants may decline the interview and not confirm their offer.

## 5.3 Interview

Applicants qualified for interview must be in the interview room at specified dates and times, approximately 9–13 January 2026. If an applicant does not report for the interview on the date and time specified by the Faculty of Law, that applicant will be disqualified.

# 5.4 Interview Assessment Criteria

The Faculty of Law will assess applicants based upon SAT score in 1.3, details in application form, Portfolio under 4.2, and English communication evaluated by the Bachelor of Laws in Business and Technology Law (International Program).

# 5.5 Announcement of qualified applicants who have passed the interview

The Faculty of Law will announce the list of qualified applicants who have passed the interview on **16 January 2026** on https://law.chula-regist.com.

The Faculty of Law may announce exactly the number of applicants who have passed the interview according to this announcement or more, in the event that the last qualifying applicants have equal scores.

6.1 A successful candidate with the right to matriculate must have received a high school diploma (Mattayom 6) or equivalent to be qualified to register as a student of Chulalongkorn University. Should it be discovered that the applicant did not complete the required education or does not possess all the qualifications, the right to matriculate will be rescinded and no application fee, confirmation fee, and university fee shall be refunded under any circumstances.

Applicants who have received a high school diploma from an international school or a foreign school that is not certified by the Ministry of Education must have their qualification certified by Chulalongkorn University Academic Testing Center as equivalent to a qualification as required by the Ministry of Education's Basic Education Core Curriculum for 2025 Academic year (http://mytcas.com).

- 6.2 Should it emerge that successful candidates who have registered as Chulalongkorn University students have provided false information in the application or false evidence in support of the application or in the registration, their right to matriculate will be rescinded. The applicant may also face criminal charges.
- 6.3 Should it be found that successful candidates with the right to matriculate at Chulalongkorn University have confirmed their offer of place in more than 1 program, their right to matriculate in all such programs will be cancelled without prior notice.
